## Highlights from the National Convention

**WASHINGTON, DC** (from [www.lwv.org](http://www.lwv.org)) – The League of Women Voters of the United States held its 46th biennial national convention in June. More than seven hundred delegates from 47 states, the District of Columbia and the Virgin Islands, attended. The four-day gathering gave League members the opportunity to celebrate the League's accomplishments on civic engagement, campaign finance and election reform and to discuss important policy issues.

"This Convention proved that the League remains a vibrant, grassroots organization," stated Kay J. Maxwell, newly re-elected LWVUS president. "We debated many of the critical issues facing citizens across the nation, including civil liberties, the death penalty, the ERA, No Child Left Behind and electronic voting. As is the League's long and storied tradition, a variety of thoughtful perspectives were expressed through dialogue and debate," Maxwell added.

The Pew Partnership for Civic Change, a national civic research organization, presented the League with their 2004 Civic Change Award. This is the first time that an organization, rather than an individual, received the award. In making the announcement, Alma Powell, Pew Partnership's national advisory board chair and a past recipient, said, "The League of Women Voters has made this country better for more than eight decades ... Its voice of wisdom and reason has raised the level of our civic conversations and given future generations the tools to create a better America."

Additional highlights of the convention included a panel discussion on "Balancing Civil Liberties and Homeland Security in a Post- September 11th Age," featuring representatives from the 9/11 Commission, Georgetown University Law Center, the Council on Foreign Relations and the Constitution Project; remarks by U.S. Senator Richard Lugar (R-IN), Chairman of the Senate Foreign Relations Committee; and an enthusiastic banquet address by famed White House correspondent Helen Thomas.

### Electronic Voting

*From a message from Kay Maxwell, President, LWVUS*

The League has a long tradition of reaching agreement through deliberative, democratic processes. There was disagreement with the LWVUS stance opposing a Voter-Verified Paper Trail (VVPT).

At convention, by following League process, we arrived at a revised interpretation of our "Citizen's Right to Vote" position. The convention resolution substituted principles and criteria – "secure, accurate, recountable, and accessible" – for language that previously took a stand on a type of technology, i.e., an individual paper confirmation for each ballot, or voter-verified paper trail (VVPT). Thus the League has moved from taking a stand on types of technology to taking a stand on the goals or principles any particular technology must fulfill. The criteria – "secure, accurate, recountable, and accessible" – are not code words for VVPT or for any other type of technology. This revised stance, based

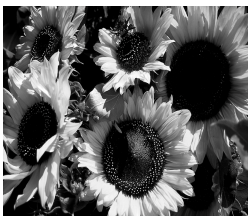


### Fundraising

In May 2003, delegates to the LWVC convention voted for an update of our Education position, last updated in 1985. The League of Women Voters of California Education Fund (LWVC/EF) will be conducting a two-year study to update its position on K-12 public education. So far, a state League committee has been formed, a scope of study adopted, and a grant has been obtained from the Hewlett Foundation. The committee will pass through “mini” grants of up to \$500 to 12 to 15 local Leagues on a first-come, first-served basis. Leagues can apply for the funding to present forums/events to include in their particular study committee processes. Joanne Leavitt is the Study Committee Chair and Barbara Inatsugu is the League of Women Voters of California Education Fund (LWVC/EF) Program Director for Education. The scope of the study is as follows:

1. a review of the existing LWVC Education position, supporting consensus reports, and study materials to identify areas that need to be revisited and updated;
2. a study of issues that have emerged since the 1983-85 LWVFC Education in California study in the areas of finance, governance, school district organization, accountability, teaching, and curriculum;
3. an updated assessment and analysis of ongoing fundamental questions regarding the separation of finance and program control, the role of the state relative to districts and school sites, articulation among levels of education, and the role of early childhood education (readiness to learn);
4. a review of the federal No Child Left Behind Act as it impacts education in California.

As a delineation of the scope of study, the following are issues for consideration: Finance, Governance, School District Organization, Accountability, Teaching, and Curriculum/Programs.

Also, if you are interested in community colleges, we can apply for mini-grants of up to \$1,000 to fund local events focusing on community colleges — El Camino, in the case if the beach cities.

on the “Citizen’s Right to Vote” position, means that:

- The League neither supports nor opposes any type of technology per se, such as Direct Recording Electronic voting machines (DREs), VVPT, or optical scan.
- Leagues may advocate for the four criteria, but it would not be appropriate to advocate for or against a type of technology, as indicated above, since that would be inflexible and would undermine technological innovation.
- Because election laws and current equipment are different in each state, Leagues in each state may support particular voting systems appropriate to them, including the management, operational and polling place procedures associated with the equipment. But before lobbying for or against a particular voting system, the system as a whole should be evaluated against the criteria — only those that meet all four criteria may be supported.

We ask that Leagues consult with the LWVUS before taking action in order to ensure that the League speaks with one voice in the application of this revised interpretation of the “Citizen’s Right to Vote” position.

The following is the text of the motion made by the President of the LWV of Minnesota and passed by convention delegates:

*“Whereas there is strong disagreement among League members on the interpretation of the position on ‘Citizen’s Right to Vote’ that the LWVUS has taken on whether a Voter Verified Paper Audit Trail should be a requirement with Direct Recording Electronic Voting.*

*Be it resolved that LWVUS remove the following wording from its interpretation: The LWVUS supports an individual audit capacity for the purposes of recounts and authentication of elections for all voting systems. The LWVUS does not believe that an individual paper confirmation for each ballot is required to achieve these goals. An individual paper confirmation for each ballot would undermine disability access requirements, raise costs and slow down the purchase or lease of machines that might be used to replace machines that don’t work. The experts that we have consulted say that there are many safeguards other than an individual paper ballot confirmation that can protect the sanctity of the ballot and that other issues are far more important in safeguarding our election systems.*

*The LWVUS interpretation of the position on ‘Citizen’s Right to Vote’ will now read: In order to ensure integrity and voter confidence in elections, the LWVUS supports the implementation of voting systems and procedures that are secure, accurate, recountable, and accessible.”*

## Status of Clean Money Bill

The California Clean Money and Fair Elections Act of 2004, AB 2949 (Hancock), promises to attract more qualified and diverse candidates, improve voter turnout, and increase attention to voters' issues. By obtaining a specified number of small contributions to demonstrate broad public support, a candidate can qualify to voluntarily accept a spending limit and then receive public funds to run a viable campaign. Safeguards exist within the regulations that allow an infusion of additional money (up to a defined maximum) to match independent expenditure campaigns or privately funded opponents' campaigns that exceed the spending limits.

The conventional wisdom among most campaign finance reformers was that AB 2949 had no chance of action in the Assembly, but on April 20th the bill was voted out of the Elections, Redistricting, and Constitutional Amendments Committee by a 5-2 margin and sent to the Appropriations Committee. Representatives from many organizations, including the League, had testified in favor of the bill.

On May 5th, the bill was heard by the Appropriations Committee. Trudy Schafer, LWVC Program Director/Advocate, testified in support of the bill. The committee held the bill on its "suspense file" where it remained on May 21st, the last day to move bills out of house-of-origin fiscal committees during this session. During this legislative session, eight Assembly Members coauthored the bill (Mullin, Steinberg, Chan, Goldberg, Jackson, Laird, Leno, and Lowenthal), as well as Senator Cedillo. Additionally, at the May 5th hearing, Assembly Members Berg, Nation, and Oropeza advised author Loni Hancock that they wished to be identified as coauthors. If you are in one of these districts, please contact and thank your representative for her or his support.



During each committee hearing, representatives of the Green Party argued strongly against AB 2949 because of its mechanism that creates separate categories for candidates to qualify, based on previous election results. Candidates representing parties that won 3 to 10 percent of votes in the previous gubernatorial election would automatically have fewer small contributions to collect but would also be limited to substantially less in matching funds. Efforts are going on to modify the qualification requirements to enable small parties to collect more signatures to demonstrate support in order to obtain full funding for the general election.

The League will continue to participate in the Campaign Finance Summit meetings in conjunction with the Clean Money organization and other groups as we explore the next steps to bring campaign reform to California. The California Clean Money Campaign has groups in many communities that are currently working to educate the public about the Clean Money concept.
