While there is a great deal of political disagreement about what steps to take and on what timeline, there is remarkable consensus amongst scientists and policy experts about the most impactful things we can do right here, right

change without drastically reducing the amount of miles we drive and the amount of fuel we burn. In the last decade, we've moved in the opposite direction--driving more miles per capita and in bigger cars/SUVs. The growth in SUV market share has consumed 33 times as much oil as all <u>electric vehicles (EV) have saved</u>. Helping people move around without cars, and in smaller cars when they do need to use one, should be a top priority. Let's think transit and electric and analog bikes before electric cars.

Land use ties together two of <u>LWVC's Key Issues for Emphasis</u>: Climate Change and Housing and Homelessness. Increasing the supply of homes near jobs and along transit corridors is critical. This allows more people to live without relying on cars for every trip. But much of the land in desirable areas close to high numbers of jobs is tied up with restrictive Single Family Home (SFH) zoning. This is why upzoning in some areas

If we modify our land use and transportation policies so that people can live their lives fully while drastically reducing the miles that they drive a car--electric or ICE (internal combustion engine)--then we can stop climate change and reduce air and water pollution, traffic congestion, and sedentary lifestyle diseases all at the same time.
