## NEWS FROM LEAGUE OF WOMEN VOTERS OF CALIFORNIA

The State League is embarking on a new project called *Make it Fair*. The focus of this project is to change the way that businesses are assessed for property tax. Under current law corporations can go decades without getting an increase in their property taxes. This proposal would change Prop 13 for businesses only. This would *not* affect residential property tax. There will be a petition drive to get this measure, "*The California Schools and Local Communities Funding Act of 2018*" enacted.

## PROGRAM PLANNING AND HOLIDAY LUNCHEON REPORT

On Saturday, December 2, 2017, fourteen LWV Beach Cities members met at Henrietta Mosley's home to participate in program planning focusing on positions adopted at the national level of our organization, and to enjoy good conversation over a potluck lunch.

With the LWVUS Summary of Public Policy Positions (enclosed with the Nov-Dec Voter) in hand, and ably guided by our President Barbara Arlow, we engaged in a lively and insightful discussion of LWVUS positions, with particular attention to those listed under the general headings of REPRESENTATIVE GOVERNMENT (Voting Rights, Election Process, Citizen Rights, Public Policy on Reproductive Choices, Congress and the Presidency) and SOCIAL POLICY (Federal Role in Public Education, Health Care, Meeting Basic Human Needs).

While we found that we were generally in agreement with retaining the positions as written, there was a consensus for making the following additions/revisions to three of the position statements, as follows:

Under REPRESENTATIVE GOVERNMENT/Election Process—Money in Politics we would add to advocacy for combating “corruption and undue influence in government” a reference to “undue influence through social media and other communication methods (e.g. print and online).”

Under SOCIAL POLICY/Federal Role in Public Education we would add to “Support federal policies that provide an equitable, quality public education for all children pre-K through grade 12” a reference to supporting adult education.

Under SOCIAL POLICY/Meeting Basic Human Needs/Housing Supply, we would amend the reference to providing “a decent home and a suitable living environment for every American family” by replacing “family” with “individual and families.”

It was also recommended that we add a note to our response to National to the effect that “Lobbyists should pursue legislation to hold all branches of government and staff accountable for predatory behavior.”

Unfortunately we did not get to all the Public Policy Positions and although there was a talk of a follow-up meeting we could not find a mutually convenient date in the busy holiday season that would allow us to get our report out to the National level in a timely manner.

After the discussion we gathered for our usual delicious holiday potluck lunch, with salads and hot dishes that, as usual, surpassed all expectations.

## League of Women Voters of California Positions on June 2018 ballot measures

The LWVC board has taken final positions on the measures scheduled for the June ballot. We'll have a **The League Recommends** (a.k.a. Vote With the League) by early April. Meanwhile, here's a quick summary of the League position on each measure:

### **Greenhouse Gas Reduction Reserve Fund (ACA 1)**

This measure would add a requirement that two thirds of legislators approve the first appropriation of any money collected from the sale by CARB of Cap-and-Trade allowances. At a time that we need efficient and effective investments in climate change solutions, this requirement could lead to deadlocks, inefficiency, and poor decisions. **The LWVC opposes this measure.**

### **Motor Vehicle Fees and Taxes (ACA 5)**

If passed, this measure would raise excise taxes on gasoline and diesel fuel, provides for regular increases to those taxes based on inflation, establishes a new fee on zero-emission vehicles, and raises vehicle registration fees. The new revenue from these taxes would be used for transportation-related purposes -- repairing streets and bridges, addressing deferred maintenance on highways and local roads, improving public transit, and investing in needed transportation infrastructure to benefit all Californians. The League supports measures to ensure adequate revenue to support needed services, including safe roads and good public transportation. **The LWVC supports this measure.**

### **Effective Date of Initiatives (ACA 17)**

Currently, an initiative that is approved takes effect the day after the election unless the measure provides otherwise. Election results are not officially certified until five weeks after the election. While most election results are clear shortly after election day, that is not always the case. Prop cc would provide that an initiative would take effect 5 days after the Secretary of State certifies the election results. This is a common-sense measure, ensuring clarity about what is – and is not – California law. **The LWVC supports this measure.**

### **California Drought, Water, Parks, Climate, Coastal Protection, and Outdoor Access for All Act (SB 5)**

This measure would authorize California to issue general obligation bonds, with the money used to finance state and local parks, water conservation measures, water reliability to disadvantaged communities, and flood protection projects. California parks provide open space and recreation, improving health and community well-being. The water projects funded by this bond are forward thinking, and are a key part of our state response to climate change. **The LWVC supports this measure.**

### **How does the League make ballot measure endorsements?**

We only take positions on ballot measures based on current policy [positions](#) and [League principles](#). Positions are developed based on grassroots member [study and consensus](#).
