PROGRAM PLANNING RESULTS

A lively program planning meeting was held in December and the LWV-Beach Cities Board met to review both National and Los Angeles County positions of the League of Women Voters in anticipation of their respective conventions this year. LWVLAC convention is in March and LWVUS convention takes place in Chicago in June. The reports were approved by our local board.

The LWVBC recommended that all current positions of the county League be retained. The issue recommended for emphasis and action was Homelessness. Inclusion of the specific wording was also recommended in view of homelessness as a major concern in Los Angeles county.

The program planning meeting for national issues also resulted in affirmation of all existing positions. Voting Rights was the overwhelming issue for emphasis and action. The members recommended the wording for Money in Politics include "measures to prevent undue influence through social media and other communication methods, both print and online."

Under the Federal Role in Public Education, it was strongly recommended that the position be changed to read: "Support federal policies that provide equitable, quality public education for all children pre-K through grade 12 "and adult education." Under Basic Human Needs, Housing Supply, the word "family" should be changed to "individual and families."

REPORT ON LOS ANGELES COUNTY WINTER LEAGUE DAY

Dean Logan, Registrar-Recorder/County Clerk Los Angeles County: First Steps toward California's **New Voting System.** The California Voter's Choice Act is designed to modernize the voting experience. Starting in 2020 Los Angeles County voting will take place for 11 days. In addition to paper sample ballots Interactive Sample Ballots (ISBs) will be available. The ISB will allow voters to premark their selections on a computer or mobile device utilizing their preferred tools at home. It generates a Poll Pass, which is similar to an airline boarding pass, where voters can scan their Poll Pass at the Ballot Marking Device (BMD). The BMD prints a verifiable paper ballot with the voter's selections. By design, the BMD is not connected to any network or the internet. It also does not store any voter data or tally votes. There will be about 400 vote centers for the first 7 days and that will increase to 800 – 900 vote centers for the final 4 days. Voters will be able to vote at any vote center throughout the County. Electronic rosters will access data in real time and allow for same day registration. Fully accessible voting equipment will be available at every vote center. Ballot Marking Devices (BMDs) will make it easy for voters to customize the voter experience to fit their needs. Voters will be able to adjust settings on the BMD including user interface contrast, text size, screen angle, and audio volume and speed. This will allow disabled voters to vote without help. The equipment will allow one to read and listen in multi languages.

Make it Fair Campaign: League-Sponsored Ballot Initiative to Amend Prop. 13

This will only apply to commercial property. Private and apartment houses are not included. Commercial properties that have not changed ownership have not been reassessed since 1975. All commercial properties purchased after 1975 are assessed at the time of purchase and therefore pay a higher tax rate. If the initiative passes pre-prop 13 commercial properties will be reassessed and all commercial properties will be reassessed every 3 years. It is estimated that will raise approximately 11 billion dollars that will go to local governments. 40% of that will go to school districts.

Dr. Raphael Sonenshein, CSULA Pat Brown Institute: "So They're Registered – How Do We Get Them to Vote?" There has to be hope to motivate voters. The League of Women Voters has credibility with people. We need to mobilize both youth and women. Youth are passionate about issues, but they don't know where to go with that passion. Women are going to be a major force in this election. This mid-term November 2018 election will determine the House of Representatives for the next two years.

HIGHLIGHTS OF EVENING WITH REP. TED LIEU

Approximately 100 people came to the Hermosa Beach Community Theater on February 1, 2018 to hear Rep. Ted Lieu. Mindful of reports of disruptions at other local gatherings where Rep. Lieu appeared, the League took special precautions to maintain control of the forum, in addition to our usual written questions and ban on holding up signs or other demonstrations. These were successful, as after one brief outburst early in the meeting, decorum was maintained. The following are notes on some of Rep. Lieu's remarks.

<u>Immigration</u>: As the son of immigrants who got a foothold in this country by opening gift shops in Cleveland, Lieu sees immigration as a force for renewal and refreshment of American society, although he recognizes the need for standards and some restrictions. He defended the family reunification program (which the President calls "chain migration"), saying that families make society more stable.

<u>The Russia investigation</u>: The likelihood of a finding of obstruction of justice is more likely than a finding of conspiracy on the part of the Trump administration. The investigation will not wrap up any time soon, as evidenced by the 90-day delay placed on Michael Flynn's sentencing.

<u>North Korea</u>: There is great potential for harm, and no good options. Talk of resorting to the "bloody nose option" is foolish because that course of action would inflame North Korea and we don't know how they'd react. Since we don't know where their nuclear weapons are, we would have to resort to a ground invasion, which at a minimum would trigger a deadly reaction affecting South Korea and our own military installations in the region and could cause Russia or China to come to North Korea's defense.

<u>Electoral college</u>: In response to a question on eliminating the electoral college, he said he supports selecting the President by popular vote.

<u>Priority infrastructure projects for the South Bay</u>: Extend the Green Line into the So. Bay. Give money to individual cities to fix streets, etc. Prepare for automated driving, which relies on "deep learning" and entails the potential for cars to be hacked. Cybersecurity needs to keep up with automated vehicle advances.
